

COMMUNITY MESSAGING IN NORTHUMBERLAND

BE INFORMED

Please find the following Coquetdale Community Message update covering the period from the 31st July to 27th August 2015.

Fourteen (14) crimes were reported over this period:

Rothbury

Assault - ABH (Domestic Violence)

Occurred 31/07/15 at a residential address in Rothbury, where the female occupant (54 yrs) was assaulted by her partner (47 yrs), sustaining minor injuries to her arm and head.

A male was arrested, charged and convicted at court with fine imposed and 12 month restraining order in place.

As previously stated, police will not tolerate domestic violence and will safeguard victims and take positive action against offenders.

Criminal Damage (Dwelling)

Occurred 18/08/15 at an address in Rothbury, where the intoxicated son (34 yrs) damaged computer, door and wardrobe property within the home.

The male was arrested, charged and will appear at court 10am 24/09/15

Burglary Other Than Dwelling Flotterton Farm

Occurred from 07/08/15 to 21/07/15 when the bolts from a secure outer farm building were removed enabling entry, where a large quantity of wire fencing was stolen.

Damage to Motor Vehicle

Damage to Dwelling

Both crimes occurred at an address in the Felton Fence area.

A male (19 yrs) caused damage to a vehicle outside the address, by smashing both headlights and damaging the bonnet.

The same male caused damage to the house window at this former home address.

Enquiries are continuing to locate the male concerned.

Occurred between 01.00hrs and 03.00 hrs 12/08/15 where a secure outer building was forcibly entered and property removed (Projen golf clubs and bag)

Public Order (threatening behaviour) Station Cottage, Whittingham

Occurred 22.20 hrs 07/08/15 when a male resident (33 yrs) threatened physical violence towards another male (50 yrs) following a dispute over parking.

The resident was arrested, charged and will appear at court 10am 27/08/15 (update awaited)

Aggravated Vehicle taking (Glanton area)

Occurred around 0100 hrs 15/08/15 when the visiting grandson (23 yrs) took the grandparents vehicle without consent and crashed the car at Powburn.

The male was arrested (Aggravated vehicle taking / drink drive) and is police bail pending further enquiries.

- 02.42 hrs 01/08/15 - Vehicle overturned at Edlingham - Lemmington Crossroads. Minor injuries to male driver (32 yrs) who was arrested drink drive and is on police bail.
- 00.08 hrs 07/08/15 - One vehicle road traffic collision - A696 Otterburn. Minor injuries to female driver who was arrested drink drive, charged and now fined and disqualified.
- 15.30 hrs 23/08/15 - One vehicle involved - m/cycle collision at Fontburn. Minor injuries to rider and pillion passenger.
- 16.19 hrs 23/08/15 - Vehicle on its roof, A696 Otterburn. Two vehicle collision. Minor injuries. Male driver (48 yrs) arrested for dangerous driving and is on police bail.

PRIORITY OBSERVATION REQUEST

There has been a recent increase in thefts of wire fencing, bail wrap and quad bikes, from remote rural farm outer buildings.

These crimes have occurred in Berwick, Alnwick and Morpeth areas

Please review security, ensure vehicles are secure and buildings locked.

Always report any suspicious persons, vehicles or activity via the emergency 999 telephone system.

Police are continuing to focus on arterial routes and visiting remote farm areas.

Joint operations are being conducted with adjacent police sectors, to target travelling criminals.

The vehicle may have ladders on the roof and is connected to the Tyne and Wear / Durham area to which enquiries are ongoing.
One male has been arrested and is currently in custody.
